1. Name of the Society : Nellore Children's Educational & Service Society, Nellore.
2. Place of Office : 17/693, Achari Street,
Nellore - 524 001.
3. Aims & Objects. :
 - a) To establish and organise systematic educational Institutions.
 - b) To impart proper education and to encourage good behaviour among the students folk.
 - c) To render necessary free education to the deserving poor.
 - d) To provide Educational Books to the poor students, free of cost.
 - e) To establish, laboratory and libraries for the benefits of the students.
 - f) To provide hostel facilities to the students of the Institution if necessary.
 - g) To administer & manage all educational Institutions established by the society.
 - h) To do social service in times of National calamities such as cyclone, (s) , floods etc.,
 - i) To receive any donations to construct and establish the educational institutions to help the student folk to promote their education to higher levels.
 - j) To provide legal and medical aids for the poor.

- l) To award prizes and scholarships to the distinguished students in various competitions conducted by the society.
- m) To help the unemployees by appointing in various posts pertaining to our educational society.
- n) To undertake new schemes offered by the State or Central , Social Welfare Departments.
- o) To inspire parents to send their children to the schools and colleges to improve ~~their~~ literacy among the masses.
- p) By collecting necessary funds through the methods and means suggested by the executive body , should be banked and the account should be maintained and properly audited once a year, and get signed by all the members of the executive committee.
- q) To educate all or any of the deeds of things necessary for the promotion and attainment of the above said ~~ends-and~~ aims and objects.

RULES AND REGULATIONS OF THE SOCIETY

1. Name of the Society : NELLORE CHILDRENS' EDUCATIONAL & SERVICE SOCIETY.
2. Place of Office : 17/693, Achari Street, NELLORE-524 003
3. Membership :
 - a) There are only seven members in the society.
 - b) Admission fee for the society is Rs. 5/-
 - c) Annual Subscription is Rs. 10/-
 - d) The admission fees is to be paid only at the time of admission only.
 - e) The annual subscription is to be paid once in a year (i.e.) it must be paid on or before First June of the Year.
 - f) Those members who have not paid their subscription for three months continuously, their membership ceases automatically.
4. General Body and its Functions :
 - a) All the seven members of the society are considered to be the General Body
 - b) If any member drops from the membership either by ~~regis~~ resignation or by death, the President of the Society shall have the right to admit another individual as a member on his place.
 - c) The General Body meeting will be held once in a year. If necessary it shall meet at any time as desired by the President.

: d) The General Body shall elect members for the governing body every year during the general body meeting, expecting the President, who shall be the permanent President for his life time.

e) The General Body shall pass the budget and approved the expenditure statement. It shall approve the reports of the governing body and pass orders. It shall have the power to amend the aims and objects and also rules and regulations in good faith in the best interest of the society.

f) The Financial year of the society shall, from 1st June to 31 May of the academic year.

g) The Quorum for the general body shall be 2/3 of the members on roll.

5. Governing Body and its functions:

a) There shall be a governing body to conduct the affairs of the Society through the office bearers. The governing body shall consists of 7 members viz.

- 1) The President
- 2) Vice President
- 3) Secretary
- 4) Joint Secretary
- 5) Treasurer and two other members.

b) The President of the governing body shall continue to hold his office permanently for his life time and he shall not be subjected to any election. The President shall have the authority to nominate his successor to him in case of death or resignation.

: c) The other office bearers and

members of the governing body shall be elected during the annual general body meeting.

d) All the properties of the society shall vest in the President.

e) The governing body shall have authority to appoint an auditor or a qualified Tax Practitioner to audit the accounts of the society.

f) The governing body shall implement the objects of the society.

g) It shall discuss the proposals made by the members.

h) It shall consider the agenda to be discussed at the General body meeting.

i) All matters shall be decided by a vote of majority of the members present. The President can exercise his casting vote in case of tie.

j) The quorum for the meeting of the governing body shall be found.

6) Office bearers and their duties

: (a) PRESIDENT:- The President shall preside over all the meetings of the general and Governing body.

(b) He shall be in over all charge of the important affairs of the society. Its administration, financial affairs of all nature and maintenance of all educational institutions run by it. He has the power to supervise, inspect, verification of accounts, records, money orders, maladministration of the affairs of the society and of the institutions run by the society.

III) He shall operate the Bank Accounts along with the Secretary and Treasurer.

IV) He shall have the right to summon, preside, prorogue emergency meetings of the Governing body either on his own motion or at the request of the majority of members.

V) The President functioning as Correspondent or Correspondents shall:

a) Look after the day today administration of the institutions run and managed by the society.

b) Shall correspond with the officers of the Educational Department, University, State and Central Government Authorities.

c) Shall be the appointing authority for all the posts sanctioned by the Government or by the Governing Body.

d) Shall be the punishing authority if all members of the Staff of the Educational institutions as well as the society.

e) Shall carry out all Government Orders, and of the University and University Grants Commission.

f) Shall have power to borrow monies as and when necessary for carrying on the administration of the institutions of the in good faith.

VI) The president shall have to acquire immovable properties in this name of behalf of the society either by share or gift in the name of the society and he shall also have the authority to all mortgage or lease out the properties of the society in the best interest of the society. All the

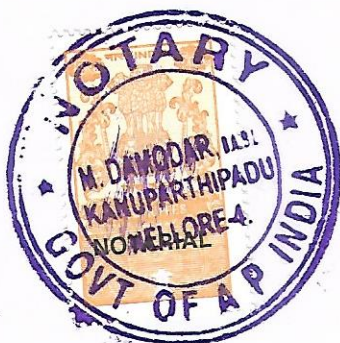
